Public Surplus takes our users' online privacy seriously. This Privacy Policy explains what information we collect about you when you visit our site, how it is used by us, and how we protect that information. The term "personal information" is used to describe information associated with a specific person that can be used to identify that person. At Public Surplus, we want to give you as much control as possible over your personal information and how that information is used.

ANONYMOUS ACCESS

You can access Public Surplus.com and browse our site without disclosing any personal information to us. We will collect certain information such as your IP address and which pages you visited for historical and statistical purposes, but this information will not be associated with your name unless and until you register and login to your account.

HOW WE USE COOKIES

Public Surplus uses "cookies" to provide our users with more customized information. A "cookie" is a small piece of text sent to your browser by a website. The browser may store the text on your computer's hard drive or memory. This helps us provide you with a faster, better, more responsive user experience. There are no third-party cookies on our site.

INFORMATION WE COLLECT

Information that you provide. We collect and store personal information that you give us when you use our services. This may include, but is not limited to the information you provide us when registering for an account such as your name, address, email address, and telephone number. We may ask you to provide us with additional personal information to authenticate and ensure the legitimacy of your account. We also collect information that you enter on our site, which may include but is not limited to your email correspondence with us, item descriptions,

and information you enter using your account or that is related to your account. Certain sellers allow buyers to pay for auction items directly on our site. Financial information that you provide, such as a shipping address, billing address, and credit card information is collected by our affiliate, PayMac, Inc.

To access and/or make changes to your personal information, login to our site with your username and password, click on "My Stuff" then "Profile." From there, you will be able to see what personal information you have given us and make any desired changes or updates.

Information from your use of our site. When you login to our site with your username and password, we collect information about your use of our site, including but not limited to page visits, searches, and transactional information such as bids made or items listed for sale.

Information from other sources. We do not collect information about users from third-party sources such as public records, government agencies, credit agencies or social media sites.

HOW WE USE YOUR INFORMATION

Use in connection with the site. We use your personal information to facilitate your selling and buying of items on our site. We may use your information to provide you with customer service and support, to send confirmation of a winning bid, to enforce the terms and conditions of our site, or to respond to a complaint from a buyer, seller or third-party.

Limited disclosure of information to third-parties. We may share your information with affiliated companies included within The Public Group, LLC site in order to provide you with additional services. Additionally, Public Surplus maintains two separate and distinct user databases: buyers and sellers (government agencies). Information from the buyer database is available to some government sellers and all government sellers are able to see information about buyers who have placed a bid on their auction. Government sellers on Public Surplus are individually verified and activated. Anonymous, unverified registrations are not allowed. This helps ensure the legitimacy of transactions between sellers and buyers. Please immediately report any violations of this policy to privacy@publicsurplus.com

We may disclose your information if we reasonably believe it is required by law or regulation, necessary to enforce our terms and conditions, or necessary to protect our rights or the rights of a third-party.

We do not market, sell, or disclose your personal information, including email addresses, to any third-party for their marketing purposes.

HOW WE PROTECT YOUR INFORMATION

We store and process your information on computers located in the United States that are protected by physical and technological security devices. We also

implement security policies and rules to protect personal information that we have collected from:

- * unauthorized access
- * improper use or disclosure by us
- * unauthorized modification by us
- * unlawful destruction or accidental loss

We make every effort to protect the personal information that you provide to us. However, because it is possible for your information to be unlawfully intercepted while transmitted over the internet or misused by third-parties to whom it is disclosed in accordance with this privacy policy, we cannot guarantee or warrant that your personal information will always remain secure and you submit that information to us at your own risk.

HOW YOU CAN PROTECT YOUR INFORMATION

We cannot protect information that you disclose to a third-party such as other buyers or sellers. Their privacy policies, if they have them, may apply to that information but our Privacy Policy does not. Your username and password are unique to your account. Remember that you are responsible for all transactions associated with it. Do not disclose your password to others or allow others to use your account. Protect your account by signing out after each visit. Do not respond to emails that request your username and password, even if they look legitimate. Emails from Public Surplus will always contain the address "@publicsurplus.com" and we will never ask you for your account password. Change your password and notify us immediately if you suspect the security of your account has been breached.
